


# 2020 ANNUAL REPORT



# CHAIRMAN'S MESSAGE

The past year has seen some significant change within the Housing Foundation. Brian Donnelly, our founding executive director, stepped down after 17 years of leading the organisation. I am pleased to pay tribute to Brian for his considerable contribution to the Housing Foundation and to the cause of affordable housing in New Zealand. He remains an influential figure in the national effort to provide safe and secure accommodation for all New Zealanders.

Dominic Foote, who has been with the Housing Foundation for 12 years, was appointed as the chief executive officer in September and taken up the challenge of leading NZHF going forward. We are very fortunate to have a person of Dominic's knowledge, experience and capability to head up Housing Foundation and to take on the continuous challenges of delivering affordable homes.

Tony Lanigan, who had been chairman of the board of trustees of NZHF for over 11 years, stepped down from this role at the beginning of this year. I feel greatly privileged to be able to take over this role, which has been made easier for me by his enormous contribution in leading the board over the past years. I would like to thank him for his service and leadership. Tony remains as a trustee.

These changes within the team and the board, whilst often tinged with a sense of loss for those leaving their roles, are part of normal business as we look to the future and longevity of the organisation and the opportunities ahead of us.

These changes take place against the affirmation of our mission, which is to assist families out of poverty and into affordable home ownership. It is our aim to increase our capacity to deliver more homes and to assist more families into either home ownership or secure, affordable tenure as renters. Access to adequate housing is a fundamental human right, acknowledged by the United Nations and by our government. We would like to make this a reality for as many people as possible.

As an organisation, we have developed specific skills in the areas in which we operate, but we are constrained in terms of capital and opportunities. We see the opportunity to build capacity by constructive partnerships with others working in related areas of endeavour. We want to develop stronger ties with other parties such as Iwi, Kainga Ora, other community housing providers and the government so that we can work in partnership with them to deliver more homes.

We are very mindful that it is not enough simply to build homes and place people in them. The journey into home ownership or secure tenure is a long and complex one which goes well beyond moving into the home. Our focus is on creating successful outcomes through paying attention to place making, support and guidance for new homeowners and on-going community development and support.

Right now, the world is a challenging place. The country's response to Covid-19 has already hit many families hard and, over the next few years, we can expect further economic challenges,

job losses and changes to the way businesses function. Whilst interest rates are at an all-time low, accessing bank funding has not become any easier. This will impact on the intending and current homeowners with whom we partner, so we need to be ready and capable to respond to these challenges. The need for our products will increase as people's circumstances change.

Over the past year we have been working hard at building capability and capacity in serving what we might call our traditional markets. We know, though, that there are many others for whom security of tenure and home ownership is a great challenge. Young people newly in the work force can struggle to find accommodation close to work opportunities. For many older New Zealanders with very little in the way of equity or savings, finding safe and affordable accommodation can be a challenge, and we know that the demand in this area will increase significantly over the next two decades.

Looking back over the year, we have completed 42 homes with 288 planned and under construction. The Waimahia development was wrapped up at the end of 2018 and by recycling returns we are now progressing a new affordable housing development in Puhinui Park in Manukau, a joint venture with CORT and Te Tumu Kainga (the Maori Trustee). This development will provide homes for almost 180 families and households, the first residents moved into their new homes in June 2020. We remain active in the Tamaki Redevelopment programme in partnership with Tamaki Regeneration Company and Kainga Ora either as providers of affordable homes or as advisors and supplier of household management services to Tamaki Regeneration Company for their shared ownership and affordable rental programmes.

We could not do what we do without two very important groups of people. Firstly, there are the homeowners, our primary partners in our business. Without their commitment, determination and sacrifice, there would be no shared home ownership or successful communities. I am humbled by their efforts towards home ownership and to improving the life and opportunities for their families. It is a source of on-going inspiration for all of us to be alongside them in the journey to home ownership and beyond.

Secondly, there is the dedicated team within Housing Foundation. For them (as for me), this is much more than a job. From top to bottom, they are committed and energised, and live the values of the organisation every day. It is a great privilege to be part of the same enterprise as such people



The key to Tony's leadership has been the ability to build a close relationship between governance and the management team. Always available to the CEO, the combination of Tony, Brian Donnelly and latterly Dominic Foote has ensured the Housing Foundation always moved forward. Ensuring Housing Foundation was always focused on innovative products which provided home ownership for whanau who were not able to achieve this goal from the more traditional for-profit housing sector.

Bringing his commercial experience from the construction sector, Tony has been able to ensure Housing Foundation provided affordable and quality housing while at the same time building an organisation which is robust and sustainable in the New Zealand housing sector.

Thank you, Tony, for all you have contributed to the Housing Foundation and Community Housing provision in New Zealand. In all but your choice of rugby teams to support, you have done a remarkable job.

It was their biggest wish to celebrate Christmas 2020 in their new home and importantly have the kids start at their new school in the new year.

Tony and Tonya along with their 3 children had been living with Tonya's Dad in his two bedroom Wiri home for over 2 years but always with the burning ambition of home ownership. Tony said the family was certainly ready to move on "we had worked with Geoff going through the Financial Capability Programme and knew we had the savings to make it happen, we just needed the Housing Foundation to give us the opportunity!"

Tonya said, "it really was so amazing when we met with Geoff and spoke about the house plans and stuff then he said, "you guys are going to be in by Christmas for sure". We almost couldn't believe it – and Jiovanni (5) and Jack (4) were very excited".

Tony explained that having a home of their own means family stability "no more moving when the house gets sold, the kids can have a stable education and when they're older the kids know they have a place they can come home to.
